INFIRMARY REMINDERS

Dear Moshava Parents,

Camp is almost upon us and we at the infirmary have a few reminders for you.

NO CAMPER WILL BE ALLOWED AT CAMP MOSHAVA WITHOUT HAVING A PROPERLY FILLED OUT MEDICAL FORM SIGNED BY YOU AND BY THE CHILD'S PHYSICIAN ON FILE VIA YOUR CAMPMINDER ACCOUNT. WE ALSO NEED A COPY OF YOUR PHARMACY/ MEDICATION PLAN CARD UPLOADED TO CAMPMINDER! PLEASE MAKE SURE TO TAKE CARE OF THIS ISSUE WELL IN ADVANCE!!!!

If your child has any allergies or has any "as needed" medications, please have him/her bring them to camp. (All medications should have the child's name, medication name, frequency needed and amount needed. We can only distribute medications that are properly labeled!) Beautiful trees and grass, dust and molds, all great irritants to the allergic, surround us.

If your child has any eye drops, taken "as needed" for allergies, please send them along. He/she might need them and it will facilitate a quicker treatment and keep your child more comfortable.

If your child has a history of asthma, currently active or even well controlled, we suggest you see his/her doctor before camp to update his/her medications and respiratory status.

ALL PRESCRIPTION MEDICATION NEED TO BE FILLED VIA J-DRUGS ONLY! EXCEPTIONS ARE: ENHALERS, EPI-PENS, OR LIQUID MEDICATIONS OR MEDICATIONS PRESCRIBED RIGHT BEFORE CAMP, WHICH NEED TO BE LABELED AND GIVEN TO THE BUS COUNSELOR WHO WILL DELIVER IT TO THE INFIRMARY.

Lastly, if your child has had any exposure to Shigella or has any of the following symptoms- loose frequent stools, abdominal pain, vomiting or fever, please have him/her see their doctor before camp for evaluation.

Please note that Moshava's policy is to notify parents of any injury that requires a visit to the infirmary and any illness that requires treatment beyond simple daily pediatric issues.

We are looking forward to a safe, healthy and fun summer. Your help in facilitating the above will guarantee a wonderful camp experience for your children.
